SUBJECT: Notice Regarding Measures against the New Type Influenza
(The 3rd Report)

Currently, the new type influenza infection is spreading in Japan.

This is to remind you again that individuals must report items described below to prevent spread of infection at the University.

There are possibilities of appropriate measures may take place including temporary closing of the University corresponding to requests from relevant authorities, infection status and other conditions. Please pay close attention to e-mails from the University and the University website for further notice.

NOTE

1. Reporting Infection

In any of the following cases, please be sure to contact the University by telephone, and follow the instructions.

When you diagnosed (or suspected) as infected with new type influenza.

When you have been identified as an individual who has (come into) close contact with a new type influenza patient.

The University will contact you as soon as the University receives the relevant information from the Security Office.

2. Reporting after Returning from Overseas

Faculty, administrative personnel or students of the University of Aizu who or shoes housemate(s) went overseas and returned to Japan must report items listed below

(Reporting Items)

Name of the reporter

Name(s) of travelers (identify each individual by “self” or “housemate” after his/her names.

Names of countries and regions traveled.

Period of the travel

Health condition after return to Japan (If no symptoms of flue are detected, please enter “nothing abnormal detected (NAD)”. If you have any symptoms,

please explain the details of the symptoms.

3. Others

(1) Preventive Measures

- Avoid crowds as much as possible when you go out.
- Put on a face mask when you are in crowds.
- Frequent hand-washing
- Gargling

Those who have asthma, those who have hepatic dysfunction, those who periodically take steroids orally and those who are pregnant are particularly encouraged to be cautious about infection.

(2) When you have the new type influenza symptoms

- Do not force yourself to come to school or work, but take rest.
- Please see a doctor and get a prescription medicine. Recuperate at home at least 7 days after from the date you started having symptoms.

Notes for when you consult at a medical institution

- Please call a medical institution such as your family doctor first before visiting the institution for consultation.
- Put on face mask when you visit medical institution.
- Tell the doctor if there are any influenza patients around you.

Symptoms of new type influenza are,

- Sudden onset of fever (38~40)
- Chills, headaches, muscle aches and diarrheas.

(Symptoms of a common cold start with sore throats and/or runny nose then gradually developing fever)

3 その他

（1）予防方法

- 人混みへの外出を避ける
- 人混みでのマスク着用
- 頻繁な手洗い

○うがい

ぜん息や肝機能障害の方、ステロイドを定期内服している方、妊娠している方は特に注意してください。

(2) 症状が出たときの行動

- 無理して登校・出勤せずに休む
- 必要に応じて治療薬をもらい、症状が始まった日から7日間は自宅療養

医療機関受診時の注意

- ・かかりつけ医など医療機関にあらかじめ電話をした上で受診
- ・受診時には必ずマスクを着用
- ・受診時に周囲でのインフルエンザ患者の有無を伝える

新型インフルエンザの症状

- ・急な発熱(38 ~ 40 度)
- ・悪寒、頭痛、筋肉痛、下痢

(風邪は、のどの痛みや鼻水で始まり、その後に徐々に熱があがるという違いがあります。)
